### REHABILITATION SERVICES IN ACCREDITATION

#### **Outpatient Service for the Developmental Age**

Outpatient rehabilitation for patients with temporary or permanent disabilities in the motor, cognitive, neuropsychological, language, and affective-relational areas. The rehabilitation work is organized by specific areas of expertise: **neuromotor**, **psychomotor** and **language**.

#### **Outpatient Service for Adults**


Rehabilitation for patients with temporary or permanent motor, cognitive, neuropsychological, language, respiratory, cardio-vascular, voice, swallowing and other disabilities, according to regional access criteria.

The rehabilitation work in **the outpatient clinic** is divided into sectors of specific expertise: **neurological and orthopaedic** surgery for patients with central and peripheral neurological diseases, degenerative diseases, outcomes of complex fractures, outcomes of surgery for prosthesis implantation and even **adolescents** with scoliosis.

## **Private Activity**

It is aimed at patients, both in adulthood and development, who do not meet the access requirements or who, under their direct responsibility, ask to use services privately. It treats the mildest disorders such as rachialgia, various pains, postural problems, "simple" orthopedic pathologies, minor scoliosis, phonatory and minor speech disorders, temporomandibular, lymphatic and vascular pathologies of lesser severity. In addition, group therapies are proposed in which proprioceptive and postural techniques are applied and are aimed at people who wish to maintain good movement functionality, improve self-perception and postural attitude. Computerized assessments are also carried out with specific programs for language, neurocognitive and neuropsychological disorders. This allows you to effectively identify any disorders and make a diagnosis. More information is available in the

For rehabilitation treatment in the outpatient clinic, it is necessary to

• the **PRESCRIPTION** of a doctor of the Regional Health Service (public), a specialist in the disability for which you are applying

- 1. the **REQUEST** of the general practitioner or pediatrician for a specialist visit
- 2. the PRESCRIPTION of a private doctor specializing in disability

#### **Access to Private Activity**

For treatments, diagnostic evaluations in the outpatient clinic, a prescription from the general practitioner or pediatrician or specialist is required

#### In addition, everyone must

- Provide the Health Card
- Valid identification document

#### SERVICE PROVIDED

Neuro-motor, language, cognitive/neuropsychological, psychomotor, phoniatric rehabilitation. Activities for the recovery of autonomy and training in the use of aids. Educational interventions. Postural therapies, application of neuromuscular tape, oral-maxillofacial therapies.

#### PATIENT RIGHT/DUTIES

The **Charter of Patients' Rights and Duties** is available at the reception and on our website.

It is essential that the patient's absences are promptly communicated. Absences of less than 5 days can be justified by filling out the appropriate form available in the Reception; Absences of more than 5 consecutive calendar days require the presentation of a medical certificate for the resumption of ongoing rehabilitation treatment .



Patients (parents or guardians of minors) have the opportunity to express their evaluation on the different aspects of the Service, enter Observations, make Complaints or propose Suggestions, on the Perceived Quality sheet; This form is available at the waiting room or can be downloaded from the website
